Hi All, Welcome to our September 2017 Wales newsletter.

NEWS. Glastir Woodland creation scheme EOI rules have now changed.

WG have reviewed procedures to help customers who did not meet the initial

selection for Glastir Woodland Creation (GWC) EOI windows, but who may wish to resubmit an EOI for the same land under the next GWC EOI.

With immediate effect, customers can submit an EOI during a current EOI window and will no longer be required to withdraw their EOI from the previous GWC EOI.

Customers who did not meet the threshold for a GWC round may still be selected under that EOI, should take-up by plans submitted be lower than the available budget.

Customers will be contacted before end of October with the outcome of their EOIs under both the 4th and 5th GWC windows. Glastir Woodland Creation Queries

A NEW report on woodland creation is "a shot in the arm"

for the £500 million forestry and timber industry in Wales, Confor said in a recent press release.



"Branching out: a new ambition for woodland policies"

launched at the Royal Welsh Show by the Welsh Assembly's Climate Change, Environment and Rural Affairs Committee. This report is a shot in the arm for the industry, which delivers half a billion pounds of annual value to the Welsh economy. It recognises that Wales is missing an enormous range of economic,

environmental and community benefits delivered by not planting enough trees and sets out a clear plan of action to put things right. It is a blueprint for a greener future.

The first recommendation delivers the central message forestry and timber businesses have been waiting for – more tree planting and especially more commercial tree planting, to provide the raw material to drive those businesses, and the wider economy, forward."

We have highlighted the fall in woodland creation over the past 20 years and the damage this will continue to cause in terms of jobs and investment in rural Wales. In that context, the emphasis on 'significantly' increasing planting rates and the mention of long term targets is very welcome. The committee recognised "constraints" on the commercial forestry sector and called for them to be addressed - by "facilitating coniferous woodland creation commercial operations on both public and private land", as well as "promoting to the farming community the commercial and other benefits of planting trees agricultural land.

The report also says "the potential for growth in the commercial forestry sector should be actively supported by Welsh Government" and we are delighted the committee has also backed the industry's ambitious targets for Wales to become self-sufficient increasingly in production and less reliant on imports, a central plank of the arguments I have put forward to the committee on behalf of Confor. There is also a call to look at building regulations to promote the use of timber in construction, which is very welcome."

In practical terms, the report calls on the Welsh Government to address the barriers to increasing planting by linking up the regulation and funding more effectively and "providing additional guidance and support to applicants". It also calls for consideration of "a presumption of

approval for applications in areas identified by the Woodland Opportunities Map as having a high suitability for woodland"

Stuart Goodall, Confor's Chief Executive, said: "Martin has been highlighting the planting decline in Wales and fighting for the industry tirelessly. His efforts have been crucially important in delivering this report. The next step is to work with politicians and a range of partners to make it happen

– and Confor will be right at the heart of those discussions."

FUNDING AND FINANCE

Funding for creating woodland and forestry management plans_is now available from the Farming Connect programme. Owners can apply for funding directly with Farming Connect and agents acting on behalf of owners can now apply for funding to supply advice on woodland management.

There are several categories for funding which can be for creating a management plan or getting certification for a woodland or forest and the funding is limited to 80% of 1500Euro (around £1000) per category of advice.

Agents wishing to become approved advisors to deliver woodland and forestry management advice under the Farming Connect Framework need to:

1. Sub-contract under one of the eight main sub- contractors for the Lot 3 Farming Connect Advisory Service contract to become an approved advisor. This means contacting one of the approved farming connect advisors and discuss terms: the advisors can be found at:

- 2. Submit CV for Screening
- 3. Submit 2 Woodland Management Plans for Assessment by IBERS (Bangor University)
- 4. Attend one Farming Connect CPD event to cover business planning.

Rural Community Development Fund offers grants which are primarily aimed at community-based organizations. The grants will provide investment funding for a wide range of activities to help meet local needs and strengthen communities so that they can grow and thrive. EOI

window is open now and closes on 12th October. Key areas for support include:

- Drawing up of community / village development plans
- Investments in small scale infrastructure including renewable energy generation and energy saving actions
- Investments in ICT including broadband
- Improving access to services investments and studies for the maintenance, restoration and upgrading of the cultural and natural heritage
- Investments in the relocation of activities and conversion of buildings with a view to improving quality of life or increasing environmental performance.

The Sustainable Management scheme will provide financial support for land management and collaboration activities. The EOI window closes on 5th September and the scheme offers grants to collaborative groups looking to:

Co-operation and Supply Chain Development scheme. The scheme aims to support the development of new products, practices, processes and technologies in the agriculture, forestry and food sectors, including:

- Small businesses working together to share production facilities and resources
- Short supply chains and local markets

 Pilot projects where the information is made publicly available and widely disseminated. EOI window opens on 18th Oct 2017 and closes on 20th Dec 2017

<u>Co-operation-supply-chain-development-</u> scheme

Countryside Productivity Scheme (CPS) in England will offer large grants between £35,000 and £1million for up to 40% of the cost of investments in certain capital items. The full list and all guidance can be found on Gov.uk. Including:

- Timber processors and harvesters which can fell, de-limb, cut to length and sort in one operation,
- Wood chippers which are crane fed
- Construction of covered areas designed specifically for processing, storage and seasoning of timber and processed firewood.

This round of CPS closes on 3rd April 2018. RPA colleagues running the scheme will be joining us at the Confor Show at Longleat on 7th & 8th September to answer questions.

CONSULTATIONS.

Taking forward Wales' sustainable management of natural resources. Consultation closes 30th September 2017. The consultation seeks views on proposals on whether potential regulatory reform is

required to:

- improve alignment of forestry and designated landscapes with the sustainable management of natural resources
- improve access to outdoors
- improve governance structures
- streamline legislation
- improve the legislative framework through introduction of modern regulatory mechanisms.

I will submit a response for Confor but I urge you all to send a response to WG and I have circulated my response to everyone.

<u>Consultation sustainable management natural resources</u>

Plant Health.

P ramorum Situation Report.

During May 2017, NRW carried out the two aerial surveillance flights and the initial findings show a possible significant spread of the disease in Ceredigion and west Powys. Main blocks where symptoms were observed are:

Tywi South & North, Myherin, Crychan

Brechfa West & East Hafod, Cwm Berwyn, Caio, Trecwn, Crynant, & Tarenig.

Following concern raised through the flight analysis, NRW instigated a survey programme to include all larch on WGWE in an area outside the CDZ in the area picked up through the flight. The total area identified for inspection is 1958 Ha, the bulk (1600 ha) lie outside the CDZ, of which 1300 ha are on Welsh Gov. Woodland Estate. The majority of sites have been visited with approximately 274 ha outstanding (185 within CDZ).

This year to date NRW have issued SPHNs on 719 ha. The majority lie in the DLZ (623 ha) with a destruction date of 31st March 2018. Of the 623 ha, over 500 is on the WGWE and just over 100ha on private woodlands.

The next surveillance flights are scheduled for w/c 11th September and any suspect sites will be visited ASAP.

Management of *P ramorum* in Wales. Further to the meeting of the Wales Tree and Plant Health Steering Group on 11th August, the Welsh Government's current policy for the management of P ramorum in Wales as follows:

- The Core Disease Zone (CDZ)/Disease Limitation Zone (DLZ) boundary should not be moved.
- NRW should focus its resources on attacking the leading edge of the disease, working from the outside in. This should involve prioritising outliers of infection and the leading edge of infection to the north and west of the new areas identified in Myherin, Tarenig and Hafod, and to the east of Crychan and Halfway forests.
- If parallel progress can be made on felling areas outside the existing CDZ to assist with the management of the disease, that should also be pursued.
- WG endorses NRW's proposal to manage socio- economic consequences by including an element of stem injection, as described in the paper about managing the disease on the Welsh Government Woodland Estate.
- The moratorium on SPHN issuance should be lifted, ie NRW should resume the process of serving SPHN's in areas outside the CDZ. As above, this should prioritise the leading edge, working from the outside in.
- At this stage WG do not intend to revise the Disease Management Strategy.
- WG will review this guidance around early November.
